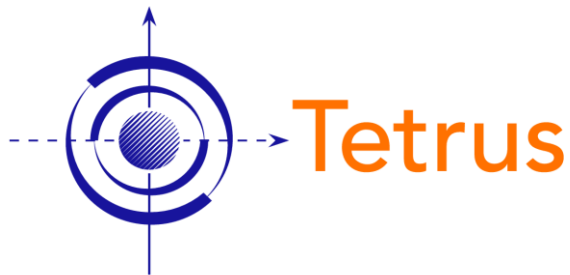


Welcome to the 2022 IJIS Institute Mid-Year Briefing and Member Forum

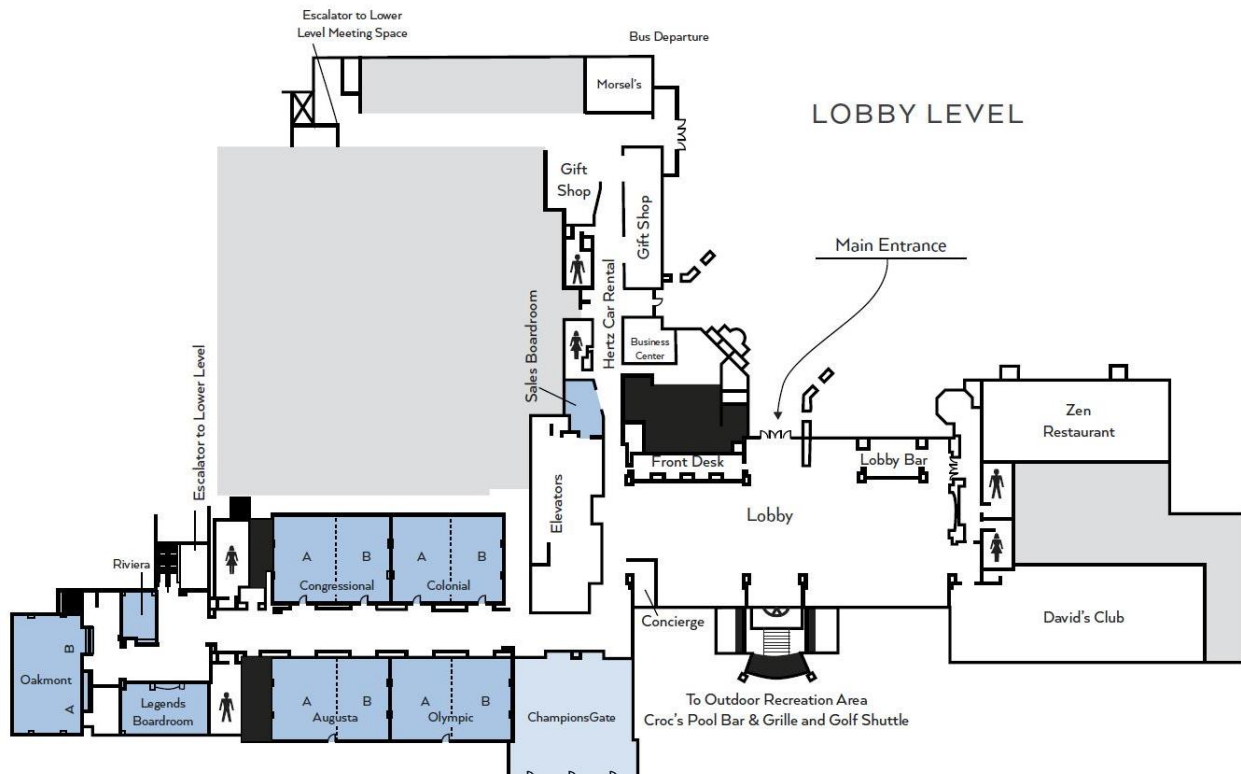

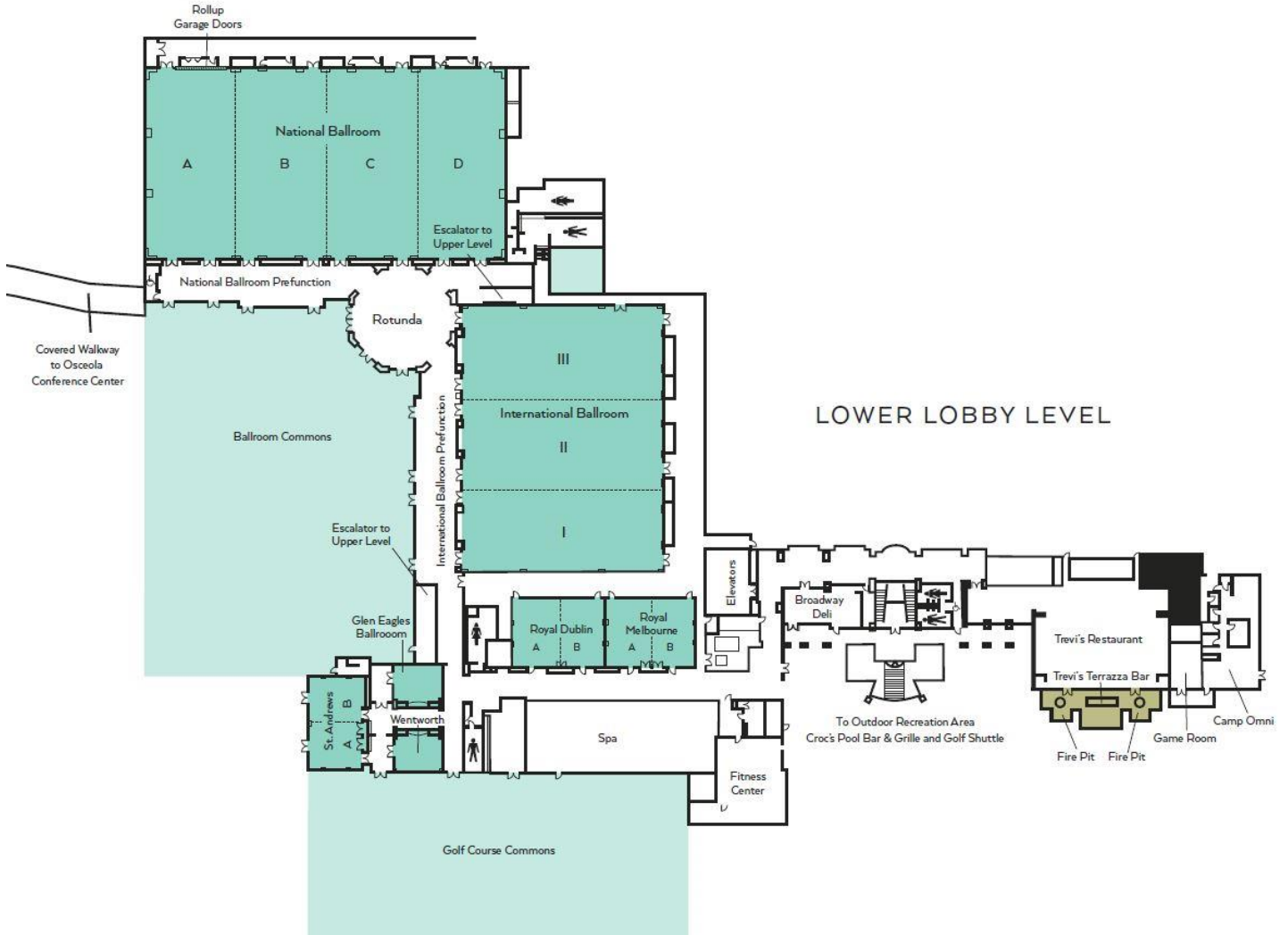
