This Call for Participation (CFP) is an invitation for your involvement in the IJIS Institute’s Law Enforcement – Information Sharing Environment Working Group (LE-ISE WG).

Working groups are constituted to provide input and recommendations to the Institute and to other organizations on specific topical areas related to a single long-term project or task. All Members are welcome to serve on any committee, and committee leadership ideally constitutes representatives from both the public and private sectors to provide a balanced perspective on the areas of interest.

Working Group Mission: The IJIS Institute Law Enforcement-Information Sharing Environment (LE-ISE) working group, in collaboration with other national practice associations, will focus on the advancement of information-sharing that is data-driven standards within the Law Enforcement (LE) communities. The current LE information sharing is very valuable to the communities they serve but enhancing data-driven information sharing based on the different types of data can provide the LE agencies with robust capabilities that will help them analyze, disseminate, and act on time. Through this working group, IJIS Institute members and partners can help to improve the level of understanding of various types of data that LE has access to, information sharing standards, and create awareness of the need to improve documentation. By offering expertise and advice on the value of data, the need for better documentation, innovative standards, and technologies, this working group will continue the IJIS Institute’s mission to unite industry and government to make LE Information Sharing valuable and successful.

Working Group Objectives: The LE-ISE WG will be publishing an issue paper, conducting webinars, reviewing and making recommendations to the LE community in collaboration with other national associations, the IJIS Board, and other IJIS committees on data-driven functionality, value of documentation, and innovative technology solutions. An IJIS Institute LE-ISE-WG can guide representation at appropriate LE conferences and other national seminars, meetings, and training sessions to facilitate discussion, new trends, and technologies for LE agencies. Members of the IJIS Institute LE-ISE-WG could also provide participation and representation on other relevant national committees and advisory groups.

Working Group Composition and Member Responsibilities: The LE-ISE WG will be composed of a chairperson, a vice-chairperson, secretary, and working group members from IJIS Institute member organizations, alliance partners, government associates, and academia. Any individual who has skills and experience that will assist the LE-ISE WG in achieving its identified mission in this effort or maintains an interest in this dynamic and important subject area is welcome to join by submitting a response to the regular calls for participation issued by the working group. All our committees have monthly conference calls. To maintain membership in the committee, members are required to attend 8 of the 10 scheduled calls each year, attend a minimum of one of the two scheduled in-person meetings each year, and coordinate and produce work products which will consist of white papers, webinar sessions, conference presentations, convening roundtables and summits, and social media outreach.



Participation Requirements and Skills Needed: Working Group members will need to be LE mission and IT professionals uniquely qualified to identify business challenges within LE agencies to facilitate and improve information sharing. Candidates for membership on this committee must have experience and expertise in the business and technology issues affecting the LE communities, the development and implementation of IT solutions and services, and relevant information-sharing standards.
